THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE UA LOCAL 350 HEALTH, WELFARE AND VACATION PLAN, (EMPLOYER IDENTIFICATION NO. 88-6003301, PLAN NO. 501) FOR THE PERIOD SEPTEMBER 1, 2017 TO AUGUST 31, 2018. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

INSURANCE INFORMATION

THE PLAN HAS CONTRACTS WITH THE UNION LABOR LIFE INSURANCE COMPANY, AND THE UNION LABOR LIFE INSURANCE COMPANY TO PAY THE FOLLOWING TYPES OF CLAIMS INCURRED UNDER THE TERMS OF THE PLAN.

CERTAIN MEDICAL, PRESCRIPTION, LIFE & AD CLAIMS

THE TOTAL PREMIUMS PAID FOR THE PLAN YEAR BEGINNING SEPTEMBER 1, 2017 AND ENDING AUGUST 31, 2018 WERE \$593,881.

BASIC FINANCIAL STATEMENT

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$6,803,610 AS OF AUGUST 31, 2018 COMPARED TO \$5,172,303 AS OF SEPTEMBER 1, 2017. DURING THE PLAN YEAR THE PLAN EXPERIENCED AN INCREASE IN ITS NET ASSETS OF \$1,631,307. THIS INCREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$11,433,701. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$11,279,158, EMPLOYEE CONTRIBUTIONS OF \$57,700 AND EARNINGS FROM INVESTMENTS OF \$96,843. PLAN EXPENSES WERE \$9,802,394. THESE EXPENSES INCLUDED \$523,967 IN ADMINISTRATIVE EXPENSES AND \$9,278,427 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
